Reg: -Policy for drawl of HRA and HRA FORMAT for identified Essential and Running staff/category in view of Estt. Srl:-75/2019 and Estt.Srl.No.103/2019 and other clarifications for allotment/retention of quarter

The following new Policy guidelines for drawl of HRA with HRA FORMAT for following mentioned identified Essential staff/category and Running staff/category and some modifications/additions in earlier Policy circular dated: 17.05.13 & 23.10.13 is issued with the approval of DRM/Adra with immediate effect for the Adra Division.

Policy circular No. SER/P/Qtrs/Policy/Allotment/HRA/Adra Division/480, Dated:- 28.12.2016 and HRA format vide No. SER/ADA/Qtr./HRA/Policy/480,dated:-28.12.2016, about HRA Policy and HRA format respectively, which was issued earlier by this office, may be treated as Cancelled.

- There are three Pools created in the Division i.e (1) Essential Pool (2) Non-Essential Pool (3) Running Pool as per guideline of Estt.Srl.No.75/2019 and Estt.Srl.No.103/2019
- Essential Staff & Running staff have to apply in Application cum Declaration as per format enclosed for Sanctioning of HRA.
- iii) Allotment of quarter has to be resorted as per the entitlement of staff as per Estt. Srl. No. 14/2011 for essential staff and Estt. Srl. No. 01/2019 for running staff for deciding about HRA in the Adra Division.
- iv) Certification of departmental Pool and Concerned Ceneral Pool will not be required for entitled type of vacant quarter in case of non- essential pool staff. They have to give an application in plain paper for drawl of HRA to Sr.DPO/Adra with forwarding by concerned in-charge for drawl of HRA.
- It the eligible type of quarter is not vacant in concerned Pool and concerning General Pool of staff then an employee can apply in format for the purpose of getting/sanctioning of HRA as per sanctioning authority mentioned in *Annexure-A* for essential & running categories.
- vi) The condemned/dilapidated condition vacant quarters should not be taken into account for the purpose of grant of HRA.
- vii) The quarters which have just become vacant after the most recent quarter Committee Meeting may be ignored as vacant quarters for purpose of grant of HRA.
- viii) Certification of Chairman/General Pool for entitled type of quarter in the HRA Format is not required, where General Pool is not in existence.
- ix) Tagging condition should not be included for drawl of HRA.
- x) Transfer of Any Rly. quarter from one Pool to another Pool will require the sanction of DRM/Adra & it will be put up through Sr.DPO/Adra
- Any vacant quarter for more than three months shall automatically go to General Pool (without any further formalities for approval etc.). Concerned SSE /Works will not give keys to any staff after vacancy of three month, without approval of DRM/Adra with the consent of Sr.DPO/Adra.
- xii) The existing Policy of item No. 12(c)&(f) of this office Policy letter dated:-17.05.2013 shall be substituted as under:-
 - Only once Exchange of Rly. Qtr. will be allowed in same type and also only once exchange in each higher type in the same place of posting (in case the staff is eligible).
- xiii) Regularisation of retained railway quarter after returning back to the parent station will require the approval of ADRM/Adra through Sr.DPO/Adra.
