NOTIFICATION

Sub: Selection for the Post of Goods Train Manager in Level-5 as per 7th CPC Pay Matrix against 60% DPQ in Operating Department of Ranchi Division.

It is proposed to conduct a general selection for filling up 22 (UR-14,SC-8,ST-0) vacancies of Goods Train Manager in Pay Level-5 in 7th CPC Pay Matrix against 60% by DPQ of Operating Department in Ranchi Division. As Such, options are invited from willing and eligible serving regular non-ministerial employees in Operating and Commercial Department with a minimum of three years regular service, working in Level-2, Level-3 and level-4.

2. Eligibility criteria and Service condition of staff

"60% by general selection from amongst serving regular employees with a minimum of three years service working in Grade Pay Rs. 1900/- (Level 2) to Rs. 2400/- (level 4) in the categories of Train Clerks (GP Rs. 2000/Level 3)/Sr.Train Clerk (GP Rs.2400/Level 4), CCTC(GP Rs.2000/Level-3), Cabinman (GP 1900/level-2)& (GP 2400/Level-4), Switchman/Leverman/Pointsman/Shuntman (GP 1900/level-2) and Asstt Guard(GP 1900/level-2), Sr.Asstt Guard (GP 2400/level-4).

(Auth: RBE Nos. 46/2017, 30/2018, 177/2018)

No individual quota of representation from these grades is fixed as per provision contained in the PCPO/GRC/SER's letter No.SER/P-HQ/ET/210/GG/DPQ dated.03.02.2018 and panel will be made on merit basis from amongst the qualified candidates.

In terms of CPO/GRC's Estt SI No.153/06, the cutoff date for determining the eligibility of the staff will be the date of issue of notification. As such the volunteering employees should stand fulfill the eligibility criteria and service condition as on the date of notification i.e. as on **24.01.2024**.

3. Procedure for examination

In terms of Estt. Sl. No RBE 196/2018, 97/2019, SER's Estt. Sl. No. 129/2019 and RBE No. 194/2019, the question paper will be 100% Objective Type. All the questions will be of multiple choices only. The written examination will be conducted on OMR sheet/CBT mode.

To ensure the authenticity of the answers

- (a) Erasing/using liquid fluid is not permitted. Hence in such case question will be treated as attempted wrong and marks will be deducted accordingly.
- (b) Multiple marking of options not permitted. Hence in such case question will be treated as attempted wrong and marks will be deducted accordingly.
- (c) Stray marking, dots, slashes is not permitted.
- (d) Only Blue Colour ball pen is to be used in examination & OMR Sheet.

Answer having correction/overwriting, Erasing/using liquid fluid, multiple marking of options will be treated as attempted wrong. There will be negative marking @1/3 mark for each wrong answer. No negative marking against non-attempted question. Duration of examination will be 90 minutes.

Question papers are required to be prepared in bilingual form i.e., English and Hindi. The staff will have the option to write their answers either in Hindi or English. The Question for about 10% of total marks allotted for written test should be set on official language policy and rules. The Question on official language policy and the rules may not, however be compulsory. Question papers will contain 110 objective question, out of which only any 100 question to be attempted. If any candidates attempt more than 100 questions, only 100 questions from the first be evaluated. If any discrepancy found in the Question of Hindi version, the only English version question will be valid

4. Mode of Selection

In terms of Estt SI No 132/2009, wherein it is laid down that "The final panel should be drawn up in the order of merit based on aggregate marks of 'Professional ability' and 'Record of service'. However a candidate must secure 60% or more marks in 'Professional ability' as well as in aggregate, for being placed on the panel. There will be no classification of candidates as 'Outstanding'.

This Selection being a Safety category, no relaxation of marks will be allowed in respect of reserved community (SC/ST) candidate. The allotment of marks under various heads for being placed on the panel as per para 219 (j) of IREM Vol I is as under:-

5. Date of examination

The date, venue and time of examination will be intimated separately. The employee may also note that no supplementary examination will be held under any circumstances.

6. Syllabus & Question bank

The syllabus prescribed for the examination is enclosed as **Annexure-II** and uploaded on Railway website www.ser.indianrailways.gov.in and all the candidates are advised to acquainted themselves with the question.

7.Training and Medical of successful candidates

The selected candidates have to pass the prescribed medical examination in Aye Two(A2) medical category and who fail in the prescribed medical examination will not entail to any right to claim for promotion of Goods Train Manager. The candidates who will pass the medical category in Aye Two(A2) will be sent for completion of prescribed promotional course training at ZRTI/Sini. Those who passed the training will be promoted as Goods Train Manager (Provisionally) and those who fail in the training will be sent back to their parent cadre.

8. Pre-selection coaching

Pre-selection coaching to eligible SC/ST employees shall be imparted as per the syllabus for a period of 03 to 04 weeks. After completion of the pre-selection coaching, a certificate has to be issued by the controlling officer to the effect that all the eligible SC/ST employees have been imparted pre-selection coaching for a period of 03 to 04 weeks covering the syllabus prescribed for the examination. In case, any employee expressed his unwillingness for pre-selection, a written declaration to that effect may be forwarded to this office positively.

9. Last date of submission of application

The willing and eligible volunteers have to submit their applications/options in prescribed proforma (Enclosed at Annexure-I) to their controlling supervisors who will forward the applications in one bunch with a covering letter to the Controlling Officer. The controlling officer has to forward all the applications in one bunch to this office on or before 19.02.2024 positively.

Applications received after the due date should not be entertained by the Controlling Officers/Supervisors. The application sent directly or in piece-meal or received after the last date by this office will not be entertained under any circumstances.

10. Other information

At any stage of selection, if any staff candidature is found to be defective or not as per extent rules, his candidature will be cancelled thereof. Thus mere calling or being eligible provisionally for the selection does not confer any right to them for such promotion. The administration also reserved the right to cancel the notification/notified vacancies at its discretion, if any discrepancy(ies) is(are) found at any stage and such decision will be final and binding on all.

This notification should be given wide publicity. All the Supervisory officials should ensure that this notification is brought to the notice of all the employees working under their control. The employees who are on leave/sick list etc. should also be intimated about notification of the selection.

N.B.: The above 22 (UR-14,SC-8,ST-0) vacancies of Goods Train Manager are provisional subject to outcome of Court Case OA No.050/00602/2019 lying pending at Hon'ble CAT/Patna Bench against cancellation of Selection of Goods Train Manager.
