The following terms and conditions may kindly be noted:-

- 1. This scheme is valid up to one year from the date of re-engagement or attaining the age of 65 years or joining of regular candidates from RRB/RRC/Departmental selection whichever is earlier.
- 2. The scheme may be extended time to time as per administrative requirements.
- Only retired Railway employees are eligible to apply. Retirement from the same Post/Categories and Department having working experience of the notified categories/post except for Ch OS/General (He/She may be from any department).
- Re-engagement shall not be beyond attaining the age of 65 years as on date of notification. No re-engaged employee should continue in service beyond 65 years of age.
- The employees Removed/Dismissed/Compulsory retired as a result of DAR action or under review are not eligible for re-engagement. Further employees retired under Safety Related Retirement Scheme (SRRS/LARSGESS) are not eligible.

- 6. The re-engaged employees are entitled only for monthly fixed remuneration i.e. reducing pension from his/her last pay drawn (i.e. Basic + DA) at the time of retirement. The monthly fixed remuneration plus full pension shall not exceed the last pay drawn at the time of retirement.
- 7. The re-engaged employee will not be eligible for any kind of leave like (CL, LAP, Sick Leave etc.). For absence if any, appropriate deduction from salary/wages will be made from the monthly remuneration.
- 8. The re-engaged employees are not entitled for any other benefit or facilities except monthly fixed remuneration.
- 9. The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
- 10. The eligibility criteria for selection of supervisors will be as follows.
  - Re-engagement shall be subject to prescribed medical fitness for the relevant category.
  - (ii) The APARs of Last three years immediate before retirement should be "Very good". If last three years APARs are not available, previous three years APARs are to be considered.
- 11. The duty hours of the re-engaged employees would be 8 hours duty or a required. The duty can be changed as per the requirement of works by the administration with weekly off for one day.
- 12. Selected staff should be posted anywhere in Unit of CKP Division.
- 13. As per SER Estt Srl. No. 227/2018, the contract of the supervisors may be terminated by either side by giving one month's notice. The performance monitoring of contractual appointees must be done on regular basis and those who are unable to discharge the duties or who fail to perform as per expectation of the administration, may be given 30 days notice and their contract will be terminated. However, in case of gross negligence/misconduct/irregularities, the engagement may be terminated with immediate effect by giving show cause notice.
- 14. While assigning the duties the safety and other operational requirements will be adequately considered.
- 15. TA/DA is payable as applicable.
- 16. Further instruction/guideline as and when to be received from Railway Board or HQ will be taken into consideration.
- 17. Xerox copy of the following documents should be attached with the application and it is mandatory.
  - (i)Service certificate (ii) Pensioner Identity Card (iii) Pension Payment Order
  - (iv) Aadhar Card (v) Pan Card (vi) Termination Office Order.
