1. Eligibility criteria:-

- a) In terms of SER Estt. Srl. Nos. 82/2018, 69/2019, 14/2021 & 94/2023, the post of Commercial-cum-Ticket Clerk against 331/3 % quota will be filled up by General Selection from staff in Level-1 &Level-2 including Safaiwalas (except whom regular avenue of promotion exists) of Operating and Commercial Departments.
- b) The staff will be eligible for promotion against 33½ % quota having minimum 02 (Two) years continuous regular service in the relevant grade as on 06.09.2024 i.e., the date of issue of this notification in terms of SER Estt. Srl. No. 58/2017.

b) In terms of SER Estt. Srl. No. 129/2019 & 238/2019 the question paper will be 100% Objective Type. All the question will be multiple choices only. The written examination will be conducted on OMR sheet/CTB mode.

d) To ensure the authenticity of answer, cutting overwriting, erasing or alteration of any type in the answer will not be accepted. Zero marks will be given for answer having correction/over writing. Further, it is to be noted that no corrections of any type on objective type answers will be permitted. In case any correction is made, that answer shall not be evaluated and zero marks will be given for answer. The following shall tantamount to correction:-

i) Cutting, ii) Overwriting, iii) Erasing, iv) Scoring off a ticket answer in multiplechoice and ticking another answer and v) Modifying the answer in any way.

3. Formation of Panel

- a) In terms of SER Estt. Srl. No. 19/2014, the UR candidates must secure 60% or more marks in Written Test as well as in aggregate for being placed in the panel. In case of SC/ST & PwBD candidates, 10% relaxation in the qualifying marks in the written examination as well as in aggregate will be allowed against the reserve vacancies. Reservation of PwBD employee will be made in accordance with instructions contained in RBE No. 74/2022 & SER Estt. Srl. No. 154/2023.
- b) In terms of SER Estt. Srl. No. 03/2023, the final panel shall be drawn in the order of merit based on aggregate marks of "Written Test" and "Record of Service".

4. Syllabus & question Bank

Syllabus (Question Bank) for the written test may be communicated by the concerned B. O. to the eligible Staff immediately on receipt of the list of eligible staff for the selection.

5. Training and Medical successful candidates

- a) The candidates whose medical category is below Bee-Two, have to undergo re-medical before being called for the examination in terms of SER Estt. Srl. No. 96/2024 (RBE No.
- b) The selected candidates have to pass the prescribed medical examination in Bee-Two medical category and who fail in the prescribed medical examination will not entail to any right to claim for promotion of Commercial-cum-Ticket Clerk. The candidates who will pass the medical category in Bee-Two will be sent to undergo prescribed promotional course training at ZRTI/SINI. Those who passed the promotional course training will be promoted as Commercial-cum-Ticket Clerk (Provisionally) and those who fails in the training will be sent back to their parent cadre.
