Ranchi Division of South Eastern Railway is going to hold a walk-in-interview on **06/01/2025** for selection of **01(one) Homeopathic Consultant on contract basis** for engagement in **Homeopathic Dispensary at Hatia** under the aegis of Staff Benefit Fund.

Hence, all willing candidates who fulfill the following eligibility criteria and agreed to the terms and conditions, are invited to participate in the walk-in-interview along-with their applications in prescribed format for selection as Homeopathic Consultant scheduled to be held on **06/01/2025** in the office of the **Sr. Divisional Personnel Officer, South Eastern Railway, Ranchi Division, Jharkhand.**

**Eligibility criteria for engagement of Homeopathic Consultant**

1. The minimum educational qualification for engagement of homeopathic consultant is BHMS with 01 year compulsory Internship or DMS/DHMS with 06 months internship in Homeopathy & having at least 01 year working experience after obtaining the degree.
2. The BHMS/DMS/DHMS degree should be recognized from any University/Board of the state Government & Central Council of Homeopathy, New Delhi.
3. Having 05 years working experience after completion of BHMS/DMS/DHMS degree, over and above item No.1.
4. Consultant must have permanent valid registration after internship training to practice Homeopathy in Jharkhand state.
5. Citizen of India.

Age- limit:- Not exceeding 53 years of age on 05/12/2024, which is relaxable by 05 years for SC/ST candidates & 03 Years for Ex-Serviceman/OBC.

Venue:- Office of the Sr. Divisional Personnel Officer, Ranchi  
Date of walk-in-interview 06/01/2025. Reporting Time:- 10:00 hours.

Necessary documents should be attached with applications:- Self attested copy of all educational/professional certificates, 02(Two) Character Certificates issued by Head of the institution where the candidate studied last and attested by 1<sup>st</sup> class Executive Magistrate/District Magistrate or Sub-Divisional Magistrate in prescribed format, Residential Certificate, working experience certificate, if any.


The applicants will have to bring all of the above original documents at the time of walk-in interview.

**Terms & conditions**

1. The engagement of consultants in the Homeopathic dispensaries would be on 8 hourly basis working on any 5 days in a week which would be valid for one year and it may be extended by one year at a time subject to satisfactory treatment & response of patients.
2. The Homeopathic dispensary will run under the aegis of SBF purely as a measure of staff welfare Medical treatment would be under Indigenous system of medicine. Dispensary will be under administrative control of Sr. DPO/RNC.
3. Monthly honorarium for Homeopathy Consultant will be as follow till further change

4. Monthly subsidy on Homeopathy medicine will be 12000/- per month.

7. The homeopathic consultant will be eligible for 10 days Casual Leave in a year.
