- 2. I agree to provide manpower to issue of unreserved tickets through UTS and take the responsibility to ensure efficient working to the satisfaction of Railway Administration.
- 3. I have agreed to take commission as quoted in my financial commission bid. The financial commission bid as per the prescribed format given in the tender document has been submitted in the tender schedule.
- 4. In the event of acceptance of the tender, I agree to observe and be bound by the terms and conditions enclosed to this tender form which have duly, signed by me, which is subject to such modifications, as deemed necessary by the Divisional Railway Manager, Ranchi / Sr. Divnl. Comml. Manager, S.E. Rly., Ranchi, for and on behalf of the President of India and agreed by me. I will enter into the agreement with the President of India acting through Sr. Divisional Commercial Manager, Ranchi within a period of 30 (thirty) days of acceptance of tender, if my bid is successful.
- 5. I have read the various terms and conditions to tender attached here to and hereby agree to abide by the said Notification and its terms and conditions. I also agree to keep this tender open for acceptance for a **period of 90 days** from the date fixed for opening the same and in default thereof, I shall be liable for forfeiture of my full earnest money. Open Tenders are invited in the prescribed format for Engagement of Station Ticket Booking Agent (STBA) on commission basis at 08 nos. of NSG-6 category stations under the jurisdiction of Ranchi Division for issue of computerized unreserved Ticket through the existing Computerized Unreserved Ticketing System (UTS) of the station. Interested persons fulfilling the stipulated conditions may apply in the format in sealed cover and to submit the tender form duly filled in all respect on 28.04.2025 between 10:30 hrs. to 15:00 hrs. in the box kept at Sr. Divisional Commercial Manager's office RNC-834003. Tender will be opened on 28.04.2025 at 15:30 hrs. The tender form will be available at Sr. Divisional Commercial Manager's office, RNC from 10:30 hrs. to 16:00 hrs. on all working days from 28.03.2025 to 28.04.2025and upto 12:00 hrs. on 28.04.2025 or can be downloaded from Railway's website (www.ser.indianrailways.gov.in) upto 12:00 hrs. of 28.04.2025. In case the date of the opening of applications is decided a holiday or a closed day for unforeseen reason, the applications will be opened on the next working day at the same time and venue.

Eligibility Criteria: -

- **A.** The applicant should be a resident of the local district in which the station is located where STBA is proposed to be engaged. Relaxation in this condition can however, be given by Sr. DCM/DCM, in case no suitable candidate of local district is eligible to be engaged as STBA.
- **B.** The applicant should not be under 18 years of age and should be at least Class 10th pass. As a proof of age, the applicant has to submit Class 10th Mark sheet/ Class 10th Board Passing Certificate which shall be considered wherein the date of birth should be clearly mentioned. As a proof of educational qualification, certificates from recognized boards should be attached.
- C. The applicant should have to produce a certificate from the police station serving his/her locality that he/she has no criminal record and no criminal case is pending against him/her. The certificate should not have been issued prior to date of notification i.e. 25.03.2025.
- **D.** STBA and his/her nominated agent should not be an ex-Railway staff who has been removed or dismissed from service on the grounds of doubtful integrity.

E. EARNEST MONEY: -

Tender form should be submitted along with an Earnest Money Deposit of ₹ 2000/- (Rupees Two Thousand only) in the mode of Demand Draft (DD) drawn from any nationalized Bank in favour of FA & CAO, S.E. Railway, Garden Reach, Kolkata, payable at Kolkata. The Tender Form received without Earnest Money will be summarily rejected.

F. COST OF TENDER FORM AND GST:-

The Cost of tender form is Rs.1180/- (₹ 1000/- + ₹ 180/- GST@ 18%) (Rupees One thousand one hundred and eighty only) should have to be deposited in the mode of Demand Draft (DD) drawn from any nationalized bank in favour of FA & CAO, S.E. Railway, Garden Reach, Kolkata, payable at Kolkata and have to be submitted along with the Tender Form. The Tender Form received without cost of tender form will summarily be rejected.

- G. SECURITY DEPOSIT: A refundable security deposit of ₹ 10,000/- (Rupees Ten Thousand only) shall have to be deposited by the selected STBAs at the respective station at which He/ She will have been selected to engage as STBA in cash and the Money Receipt so generated should have to be kept safely by the STBA. On completion/termination of agreement, pending dues will be adjusted from the security deposit and balance refunded to STBA. The Security deposit may however, be enhanced by the Divisional/Zonal Railway if considered necessary keeping in view the sales at the station. In case STBA expresses inability to operate the counter(s) after his/her selection, the security deposit furnished by him/her shall be forfeited and deposited in Railway accounts as per procedure.
- H. The candidate who opts for the least commission in the (4% commission slab) on monthly sales turnover shall be engaged as an STBA. Applicants should have to quote as per 4 % commission Slab. In case, more than one applicant quotes the same rate, the selection will be done by drawing lots in a transparent manner in public. Sub-zero quoting of commission (Below zero %) will summarily be rejected. The commission will be calculated on monthly basis as per Railway Board's letter no. 99/TG-IV/Halts/Policy dtd. 08.09.2000 and as per IRCM Vol.II para 2425 item no. 28.

I. Railway Administration reserves the right for deduction of Railway dues from Security deposit amount on the following grounds: -

- i) Any amount paid to Central/State Government or any local Government bodies for any taxes or fines as imposed by them due to the negligent act of the STBA.
- ii) Any amount which Railway Administration become liable to pay to the state or Central Government, Local Municipal Administration or any third party on behalf of any default of the contractor or any of his/her/servant/agent serving as STBA.
- iii) Any payment/fine made under the order/judgment of any court/consumer Forum or Law enforcing agency due to the negligent act of the STBA.
- iv) Once the amount under this clause is debited, the STBA will restore the amount of security deposit to the extent the amount is debited within 15 (fifteen) days, failing which, it will be treated as breach of agreement and the contract will be summarily cancelled.
- v) If the STBA intends to discontinue/terminate the contract either fully or partially in intermediate stage of the contractual period or fails to make payment any other Railway dues, to be paid in advance for any reason whatsoever, the entire Security Deposit will be forfeited and he will be debarred for participation in any of the tender in Ranchi Division for 2 years from the date of termination.
- vi) In case STBA expresses inability to operate the counter(s) after his/her selection by Railways, the bank guarantee as well as security deposit furnished by him shall be forfeited and deposited in Railway accounts as per procedure and will be debarred for participation in any of the tender in Ranchi Division for 02 years from the date of termination.

Terms and Condition

- **1.** One applicant can be appointed as STBA at only one Station.
- **2.** The basis of selection of STBA shall be the lowest commission quoted in the slab-3 of more than Rs.1,00,000/- turnover.
- 3. The cost of hardware and software (including maintenance), electricity and hiring of channel will be borne by the railway. The space will also be provided to them by the Railway free of cost.
- 4. STBA will not sublet/assign or transfer the rights or obligation arising out of the agreement. In case of death of licensee, the license will be transferred to his/her legal heir(s) for the unexpired period of license by the competent authority subject to fulfillment of the basic eligibility criteria for engagement as STBA.
- 5. The STBA shall be allowed to sell all types of non-concessional unreserved tickets issued through UTS including Platform tickets and season tickets. Renewal of season tickets shall also be permitted. However, all other concessional tickets requiring documentary proof before issue of ticket, can also be issued by STBA only when endorsed and permitted by the SM/ASM/CI/CCI of the concerned station, which shall be done prior to the sale of such concessional tickets.
- **6**. The calculation of commission may be done on monthly basis. However, the rate of commission for a particular month may be calculated on the basis of cumulative sales turnover upto that month.
- 7. The STBA shall deposit the cash collected through sale of tickets, to the concerned Station Master / Asstt. Station Master of the station on duty on 08 hourly shift basis prevalent on Indian Railways i.e. at 06:00 hrs., 14:00 hrs. & 22:00 hrs.
- 8. If the ticket activity stops due to non-availability of STBA or due to his/her negligence resulting in non-functioning of equipment, penalty equal to the average daily turnover from sale of UTS tickets from that location, subject to a minimum of Rs. 2000/- (Rupees Two Thousand) per day shall be imposed. Penalty upto Rs. 500/- (Rupees Five Hundred) may be imposed against established public complaints regarding the functioning of STBA.
- 9. Only one STBA will be engaged at each station. STBA will not sublet / assign or transfer the right or obligation arising out of the contract. The STBA so selected, has to operate the UTS counter round the clock in all days of week in 3 shifts and as per availability of train at that particular station. However, the STBA if so desires, may nominate person(s) with the approval of SR. DCM/DCM to operate UTS counter at other shifts (which are not operated by STBA himself/herself) so that the UTS ticket selling activity may not be hampered. The nominated person(s) of STBA must possess/fulfill all the eligibility criteria of STBA. Copies of documents in respect of fulfillment of the said criteria must be submitted to Sr. DCM/RNC prior to commencement of contract.
- **10.** Both the STBA and the additional persons nominated by him/her to sell tickets shall be issued a photo identity card by Sr. DCM/DCM, Ranchi and their names will also be displayed on a notice board at the station premises.
- 11. In case of death of licensee, the license will be transferred to his/her legal heir(s) for the unexpired period of the license by the competent authority and the legal heir(s) will also be eligible to apply for extension of license as per the provision of the policy.
- **12.** The disbursement of unreserved tickets by STBA will be governed by the timings as decided by the Railway Administration, keeping in view the local conditions.
- **13.** The facility of NI (Non-issue) of tickets will be available to the STBA only when authorized / endorsed by concerned Station Master / Asstt. Station Master / CCI / CI.
- **14.** Cancellation of Ticket: The facility of cancellation of tickets may be extended to STBA only when authorized / endorsed by concerned Station Master/Asstt. Station Master/CCI/CI.
- **15.** The Railway officer in charge of the station i.e. Station Master / Asstt. Station Master will be responsible for the safe custody of the ticket rolls. It will be his duty to daily handover / take over the ticket rolls from the STBA. Proper ticket roll issued to the STBA shall be maintained at stations.
- **16.** Shift summary and daily summary of transaction details done by STBA shall be extracted through UTS and STBA should deposit the cash accordingly to the Station Master / Assistant Station Master at the end of the shift / day.

- 17. During the shift wise working hours of ticket sale, STBA will be responsible for safe custody of ticket rolls handed over to him by the Station Authorities (on duty SM/ASM). In case of any loss on this account, necessary debit will be raised against him/her as per extant rules.
- **18.** A consolidated statement of ticket rolls supplied and details of ticket sold by STBA will be submitted by the Station Master/Asstt. Station Master or any other nominated officer to Sr. DCM/ DCM every month.
- **19.** The STBA will be responsible for all errors oversight and under charges made by his/her representative/ person nominated by him/her during the assigned job of ticket selling.
- **20.** The Divisional Authorities will keep back up arrangement to take care of unforeseen circumstances such as happening of any unprecedented circumstance or seasonal rush where tickets are required to be disbursed by Railway staff also. CI/SM/ASMs posted at the station will be conversant with the functioning of UTS by giving the STBA suitable training/refresher course, if required.
- **21.** Zonal Railway will have powers to prescribe working guidelines within the frame work of the scheme.

SPECIAL CONDITIONS OF TENDER

- i) The STBA shall be deemed to be the agent of the Railway Administration and shall be subject to all the legal liabilities of agents as laid down or defined in the law relating to agents in India for issuing of tickets for the booking of passengers.
- **ii)** The STBA will give a declaration that he/she has not been appointed as STBA at any other station in the Indian Railway.
- **iii)** As in the case of normal functioning of UTS, STBA shall have to work round the clock. The procedure of working of STBA and maintaining record by him will be governed by the instructions given herein below.
- **iv)** If the STBA fails and/or neglects at any time to arrange uninterrupted services in the sale of tickets as per working hours prescribed by the Railway Administration, the Railway Administration shall have the right to make its own arrangement for selling tickets at the station and all expenses incurred in connection with the above and any other expenditure incurred by the Railway shall be recoverable from the STBA.
- **v)** The engagement of STBA will not confer any right on him/her for employment in Railways. Such engagement is purely contractual in nature and no facilities viz. absorption in railway service, regularization of service, bonus, railway pass facilities etc. shall accrue to the STBA.
- **vi)** The Railway Administration reserves the right to deduct Railway dues from the STBA's commission/ Security Deposit in case any fine or payment made under an order/judgment of any Court/Consumer Forum or law enforcing agency or any person working on their behalf.
- **vii)** The Railway Administration will not be held responsible for death or injury to any operator, Labour during execution of the work as a STBA.
- **viii)** The STBA will execute the work under supervision of the Commercial Inspector & Station in-charge (SM/ASM) of the Station as per description and Terms & Conditions given in the Agreement.

- **ix)** The STBA will be held responsible for proper handling of Railway Properties during execution of work. In case any damage is caused to Railway Property due to manhandling or loss incurred to the Railway by STBA or his worker, the damage or loss will be compensated by him/her.
- **x)** The Railway Administration shall not be liable to pay a compensation either monetary or otherwise to the labour / representative of the STBA in any circumstances.
- **xi)** The STBA shall indemnify the Railway from any claim/compensation/cost/penalty arising out of non-compliance/non-payment of compensation/taxes etc. out of the contract.
- **xii)** Any modification of norms/rules/procedure as issued from time to time by the Competent Authority shall automatically be applicable for the working of STBA.

Commission payable

Out of the applicant fulfilling the eligibility condition, the candidate(s) who opts for the least commission (On the slab 3) will be selected as STBA. The commission payable shall be as follows: -

| Slabs | Sales turnover in Rs. | Rate at which commission Payable |

The commission will be calculated on monthly basis as is being done for Halt Agents (Board's letter no.99/TG-IV/Halts/Policy dated.08.09.2000) and as per IRCM vol.II para 2425 item no.28.Commission to STBAs shall be paid from the Station Earnings. The commission shall be paid on the amount credited to Railway's account. The rate of commission for a particular month will be calculated on the basis of cumulative sales turnover upto that month. In case of concessional tickets, the commission shall be calculated on the actual fare collected by the Railways.

<u>Period of contract: - Initial period of contract will be for 03 (Three) years.</u> An agreement will be executed by the STBA with Sr. DCM/DCM of South Eastern Railway, Ranchi. Fresh tender shall be floated well before the expiry of three years. In case of delay in finalization of tender, the existing agreement may be extended for 6 months or till finalization of new agreement as per this scheme, whichever is earlier.

Termination of contract: - Each side can terminate the contract without assigning reasons by giving a notice of 30 days and will lend flexibility for checking fraudulent practice by the STBA. However, in case of fraud/criminal case, Railway shall be at liberty to terminate the contract without giving any prior notice.

<u>Disabling clause:</u> -Engagement as STBA shall not confer any right and/ or claim whatsoever on the person to seek employment in Railways. The Engagement is purely contractual in nature and no facilities viz. absorption in railway service, regularization of service, bonus, railway pass facilities etc. shall accrue to the STBA or his/her legal heirs. No claim in this regard shall be entertained. The STBA shall keep Railways free from any liabilities in present or future.

NOTE: - "In case STBA expresses inability to operate the counter(s) after his/her selection by Zonal Railways, the Security Deposit furnished by him/her in the form of Money Receipt (MR) shall be forfeited and deposited in Railway accounts as per procedure and will be debarred for participation in any of the tender in Ranchi Division for 02 years from the date of termination.

ARBITRATION

In the event of any dispute, controversy or claim of any kind or nature arising under or in connection with this agreement between the parties, the standard arbitration clause shall be applicable.
