Eligible SC/ST candidates who have opted for the subject selection should be imparted pre-selection coaching for 03 or 04 weeks on the syllabus enclosed as per extant rules and coaching completion certificate to this effect must reach to Sr.DPO/ADA's office before the written examination, failing which he/she will not be allowed to appear at the selection. Pre-selection coaching should be completed on or before 03.06.2015.

If any candidate is subsequently, found ineligible for the above selection at any stage, his/her candidature will be rejected without assigning any reason.

All the Supervisors concerned (I/c) of the staff concerned should inform each and every candidate and if any one expresses unwillingness for the written examination, his written statement should be obtained and sent to the office of the undersigned well in advance.


