All the staff (**except those who retired from Ry. service and whose lien has been terminated from SER**) should be directed/spared to appear in the examination with proper identification memo on the schedule date, time and venue. For this purpose, they would report to Shri Utpal Saha, Dy. CE/TM/GRC. **Special care should be taken to ensure that notice of examination date is reached to all candidates.**

Note: If any candidate is subsequently found ineligible for the above selection at any stage his/her candidature will be rejected without assigning any reason. It may also be noted that there will be no supplementary written test for the absentees under any circumstances.

This should be got noted by the candidates. In case, any candidate is on leave or on deputation or working in other Railways/Units or on sick list, the Controlling Officer concerned should send necessary advice to the authority under whom he/she is working or the Medical Authority as the case may be and an acknowledgement obtained.
