- 6) Staff concerned should be free from SPE/Vig. /D&A cases at the time of final release.
- 7) The extant rules regarding vacation of Rly.Qrs. and handing over of Rly. Materials should be followed before moving on transfer.
- 8) The whole exercise of sparing and reporting of both the staff should be completed within 10 days in terms of direction of Rly.Bd vide No. E (Rep) III/CPTRAN/Monitoring dt 28.04.15.
