Sub: Terms and conditions applicable to Medical Practitioners/
Dental Surgeons on contract basis.

The existing provisions regulating grant of monthly remuneration for medical practitioners engaged on contract basis contained in Board's letter of even number dated 20.12.02 have since been reviewed by the Board and it has been decided to grant monthly remuneration at the following rates to the Medical Practitioners/ Dental Surgeons engaged on the Railways:

2. The remuneration specified at para 1 above includes the following amount as HRA in case of full time contract doctors.

General Duty Medical Practitioners	Rs. 2,437.00
Specialists	Rs. 3,046.00
Super Specialists	Rs. 3,656.00


In case of full-time contract doctors for whom railway accommodation is provided, an amount equivalent to the sum of HRA (as indicated above) and license fee of the accommodation so provided be deducted from the monthly remuneration of the concerned medical practitioner.

3. The daily rate of deduction of remuneration for absence, in excess of eligibility, should be as indicated below:


