विषय/ Sub: Delegation of powers of re-appropriation

References have been received from some Railways seeking clarification regarding re-appropriation of funds between Pink Book 'works' and 'lumpsum provision for works costing below Rs.2.5 crore each' under a source and planhead.

2. It is clarified that the above is not restricted under Para "B.Restrictions" of Board's reappropriation orders mentioned above. Therefore, as per Para "C.Delegation of Powers", under C,I(c) of the above letter, zonal Railways are delegated the powers to redistribute funds between/among Pink Book items within a planhead and within an allocation (source of fund); upto-Rs.2.5 crore. Since both 'itemised works' as well as 'lumpsum provision for works costing below Rs,2,5 crore each' are Pink Book items, the reappropriation between/among them is permitted as per these instructions.
