

14. Sri Gopal Biswas, AEEE/GRC is transferred and posted as ADEE/OP/TATA vice Sri U.K.Panda transferred vide item 12 above. .

Note: -

- (i) The above promotion under Sl.No.1&3 to JA Grade (Adhoc) and Sl.No.6,8,9&10 to Sr.Scale has the approval of the General Manager, subject to their not undergoing any punishment under Vig./SPE/D&A case.


