NOTIFICATION

Sub: Re-engagement of Retired staff on monthly remuneration basis in exigencies of services on Adra Division, S.E.Railway.

In terms of Railway Board's letter No. E (NG)II/2007/RC-4/CORE/1 dated 16.10.2017 (RBE No.150/2017) circulated under CPO/GRC's Estt. Srl. No.168/2017 it has been decided to fill up following vacancies in Adra Division by Re-engagement of staff, who have retired from Adra Division, S.E.Railway.

Therefore, applications of staff who have retired from railway service of Adra Division, S.E.Railway are called for to reach Engg (Genl) section (Drop Box) of Sr.DPO's Office on or before 12.01.2018 at 18.00 Hrs..

The following terms and condition may kindly noted:-

- (1) The scheme is valid up to 14.09.2018
- (2) Retired staff who have retired from Adra Division, S.E.Railway and from the same category and same Deptt. for which Notification is issued can apply.
- (3) The re-engagement shall be strictly up to 14.09.2018 or attaining the age of 62 years or till the availability of regular candidates from RRC/RRB/ Departmental Selection whichever is earlier.
- (4) Maximum age limit for re-engagement is 62 years as on 14.09.2018. Hence, the candidate should born on or after 15.09.1956. No reengagement employee should continue in service beyond 62 years of age.

- (5) The administration is at liberty to terminate the services of re-engagement employees even before 14.09.2018 in case their work / conduct is found unsatisfactory by giving a notice of 07 days.
- (6) The employees Removed/ Dismissed/Compulsory retired as a result of disciplinary action or in review are not eligible for re-engagement. Further employees retired under SRRS/LARSGESS will not be eligible.
- (7) The re-engaged employees are entitled only for monthly fixed remuneration i.e. reducing pension from his/her last pay drawn (i.e. Basic+ DA) at the time retirement. The monthly fixed remuneration plus full pension should not exceed the last pay drawn at the time of retirement.
- (8) The Re-engaged employee will not be eligible for any kind of leave (like CL, LAP, Sick Leave etc.). For absence if any, appropriate deduction will be made from the monthly remuneration.
- (9) The Re-engaged employees are not entitle for any other benefit or facilities except the monthly fixed remuneration.
- (10) The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
- (11) Re-engagement shall be subject to prescribed Medical fitness (i.e. A3) for the above mentioned category.
- (12) Suitability /Competency of the applicant shall be adjudged by nominated committee before their re-engagement.
- (13) Copy of any of the following documents should be attached with the application and it is mandatory.
 - (a) Service Certificate b. Pensioner Identity Card c. Pension Payment Order
- (14) The last date of submission of the application is 12.01.2018. Staff retired from Adra Division, S.E.Railway desirous for re-engagement, have to submit their applications in the prescribed format at Annexure A in the box kept in Engg (Genl) section (Drop Box) of Sr.DPO's Office on or before 12.01.2018 at 18.00 Hrs.
