

3. The above employees are eligible to opt for fixation of pay the promoted grade in terms of Rly. Bd's Ir. No. P&A(1/81-22-3, dtd. 13.11.1981, Estt. Srl. No. 231/81) and RBE No. 79/2017 within one month from the date of promotion. Option once exercise shall be final. If any of the above employees already granted financial upgradation under MACPs to the Level - 03 & 04 (Grade Pay of ₹ 2000/- & 2400/-) are not entitled for fixation of Pay on promotion.
4. The promotion/posting order of Sl. No. 34 to 41 of Memo No. PERS/RNC/149/17 dtd. 09.11.2017 will be issued on or after completion of their twoyears of service as Technician Gr.III/Ancillary vide Estt. Srl. No. 55/2006.
5. This has the approval of the competent authority.




