- 1) **For Chief Vigilance Inspector/Engg:-** a) Staff working in Engineering department(SSEs/Permanent Way, Works, Bridge and Design and Drawing) in Railway in Level-7(7th PC) or (b) JEs(Permanent Way, Works, Bridge and Design and Drawing) in Railway in Level-6(7th PC)on regular basis may apply.

- 2) **For Chief Vigilance Inspector/Mech:** SSEs working in Mechanical department in Railway in Level-7(7th PC) or one scale below i.e JEs in Level-6(7th PC) on a regular basis may apply.
- 3) **For Chief Vigilance Inspector/S & T:** SSEs working in Signal & Telecom Department in Railway in Level-7(7th PC) or one scale below i.e JEs in Level-6(7th PC) on a regular basis may apply
- 4) **For Chief Vigilance Inspector/Accounts:** Staff working in Accounts Department in Railway in Level-7(7th PC) or one scale below i.e in Level-6(7th PC) on a regular basis may apply
- 5) Candidate should have completed at least five(05) years continuous Service as on the last date of receipt of application.
- 6) Candidate must have sound integrity and should not be figuring in any current Vigilance /SPE/DAR case. No Penalty (Major or Minor) should have been imposed in any past Vigilance case.
- 7) Application of the Candidate who have already completed their tenure in Vigilance Organization of Zonal Railway/Unit/Railway Board as Investigating Inspector (Vigilance) or Vigilance Inspector shall not be considered.

Procedure for Submission of Application.

- 1) Application should be submitted in the prescribed proforma , and should be forwarded through the proper channel . Application not received through proper channel will be summarily rejected. No direct application(Advance copy) will be entertained .
- 2) Application as per enclosed proforma, must be filled in and signed by the candidate himself/herself , giving the correct information to the best of his/her knowledge . No alteration /correction in the application will be entertained . Applicants must note that if any information furnished by him/her is found to be false at any stage , the application/ candidature will be liable to be rejected .Submission of false or misleading information by the applicant may lead to DAR action.
- 3) The application /option should reach to the Office of the Chief Vigilance Officer(G), Vigilance Office, South Eastern Railway, 11, Garden Reach Road, Kolkata -700043 latest by 17.01.2018 duly forwarded through proper channel ,along with attested photograph.

Other Conditions.

- 1) The normal establishment rules applicable to the regular selection post are not applicable in the selection of Vigilance Inspector(as per para 1208.2 of



Indian Railway Vigilance Manual). Mode of selection will rest with the Vigilance Organization. Adequate knowledge of DAR proceeding and computer proficiency is desirable. Preference will be given to the candidate having working knowledge of computer.

- 2) The Vigilance works is mainly out door, involving travelling , candidates should have interest and physical fitness for the same.
- 3) Selected applicants, will not be allowed to withdraw their names .
- 4) It may be noted that it will be compulsory to release the employee after selection.
- 5) All Candidates should note that persons selected and posted as CVI will have to give a written undertaking that he/she on being repatriated from Vigilance Organization will not acts as Defence Assistant to any employee facing DAR enquiry arising out of Vigilance /CBI cases for four years from the date of his /her repatriation.
- 6) The posting in the Vigilance Organization is a purely temporary basis and the Railway Administration has a right to repatriate the person any time without assigning any reason, even though he has not completed initial period of tenure or extension.
- 7) Vacant posts of the Vigilance Branch are ex-cadre posts. Therefore, staff selected for posting in the Vigilance Department will continue to maintain their lien and seniority in their parent cadre.

Application received after due date will not be considered at any circumstances.
