Sub:- Re-Engagement of retired staff on monthly remuneration basis in exigencies of Services on Ranchi Division, S.E.Railway.

In term of Railway Board's letter No.E(NG)II/2007/RC-4/CORE/1 Dated 16.10.2017(RBE No.150/2017) circulated under CPO/GRC's Esstt SI.No-168/2017 followed by Railway Board letter No-E(NG)-II/2007/RC/CORE/1 dated-12.12.17(RBE No.193/2017), it has been decided to fill up following vacancies in Ranchi Division by Re-engagement of staff, who have retired from Ranchi Division, S.E.Railway. Therefore, applications of staff in prescribed format in annexure A who have retired from railway service from Ranchi Division,S.E.Railway are invited to reach Recruitment section (Drop Box) of Sr.DPO's office Ranchi on and before last working day of the month by 18.00 hrs.

The following terms and condition may kindly be noted:-

- 1.The scheme is valid up to 01.12.2019.
2. Retired staff who have retired from Ranchi Divion, S.E.Railway from the same category/Trade and same Deptt for which Notification is issued can apply.
3. The re-engagement shall be strictly up to 01.12.2019or validity of scheme or attaining the age of 65 years or on joining of regular candidates from RRB/RRC/Departmental selection whichever is earlier.
- 4.maximum age limit for re-engagement is 65 years as on 01.12.2019. Hence the candidate should be born on or after 02.12.54. No re-engaged employee should continue in service beyond 65 years of age.

5.The administration is liberty to terminate the services of re-engaged employees any time in case their work/conduct is found unsatisfactory by giving a notice of 07 days.

6.The employees Removed/dismissed/Compulsorily retired as a result of disciplinary action or by review under Rule1802 are not eligible for re-engagement. Further employees retired under LARSGESS will not be eligible.

7.The re-engaged employees are entitled only for monthly fixed remuneration i.e. reducing pension from his/her last pay drawn (i.e.Basic+DA) at the time of retirement. The monthly fixed remuneration plus full pension shall not exceed the last pat drawn at the time of retirement.

8.The Re-engaged employees will not be eligible for any kind of leave(like CL,LAP,Sick Leave Etc.) For absence if any, appropriate deduction will be made on pro-rata basis from the monthly remuneration.

9.The re-engaged employees are not entitled for any other benefit or facilities except fixed monthly remuneration.

10.The retired employees shall execute an agreement to abide by all the terms and conditions of the re-engagement. Re-engagement shall be subject to prescribed Medical fitness for the above mentioned categories.

11.Suitability/Competency of the applicant shall be adjudged by nominated committee before their re-engagement based on APAR of last three years, awards, Education Qualification and overall assessment authority based on past experience/safety records/field knowledge/competency. Candidate to secure min 60% marks both safety and non safety category in overall to be eligible.

12.Selected staff Should be posted anywhere in Unit of Ranchi Division.

13.Copy of any of the following documents should be attached with the application and it is mandatory.

(a) Service Certificate,(b)Pensioner Identity Card,(c)Pension Payment Order,(d) Termination Office Order,(e) Aadhaar Card,(f) PAN Card.

14.Further instruction / guideline as and when to be received from railway board or H.Q will be taken into consideration.

15.The vacancy will be notified hence forth on monthly basis 10th of every month, on Ranchi Division website www.ser.indianrailways.gov.in and in the notice Board. Candidate willing to apply , can do so by last working day of the month.
