Note-

- 1) The above mentioned staff have been found suitable for the financial up-gradation under MACP scheme in terms of Estt.Srl.No.120/2009, by the duly constituted screening committee with the approval of ADRM/Adra.
- 2) The above up-gradation is admissible subject to the staff concerned being free from punishments such as stoppage of increment, reduction to lower stage or grade pay etc.(other than stoppage of Pass/P.T.O) on the date of effect.
- 3) Staff concerned should submit his option under rule 1313(1)(a)(i) of the IREC Vol.II (6th edition) 1987, 2nd reprint 2005 FR- 22(1)(a)(i) to get their pay fixation in the higher grade pay either from the date of effect of Up gradation or from the date of next increment viz. 1st July of the year as per extant rule.
- 4) On the grant of financial up-gradation under the MACP scheme there shall be no change in the designation, classification or status.
- 5) The MACP contemplates merely placement on personal basis in the immediate higher grade Pay/ financial benefits only and shall not amount to actual/financial promotion of the employees concerned. Therefore, no reservation Orders/Roster shall apply to the MACPs..
- 6) Financial up-gradation under the MACPs shall be purely personal to the employee and shall have no relevance to their seniority position. As such there shall be no additional financial up-gradation/stepping up of any for the senior employees on the ground that the junior employee has got higher Pay/Grade Pay under the MACP.
