


- 1) Srl.Nos 1 is transferred in his existing capacity, Grade Pay and Level on administrative ground.

- 3) They should vacate their Rly.Qtrs. and hand over the Rly Materials if any in their possession at the respective existing station before moving on transfer as per rule.
- 4) The minimum tenure of 02 years on a particular post at a time will apply in terms of instruction of Rly.Board (Esstt.Srl.No. 150/15).
- 5) The date of joining at the new station should be intimated to this office for record.
- 6) This issues with the approval of the competent authority on the recommendation of the placement committee.
