- The following orders are issued with the approval of the General Manager: -

**Note: -**

- (i) The above promotion under Sl.No.4,6,8 & 10 to Sr.Scale has the approval of the General Manager, subject to their not undergoing any punishment under Vig./SPE/D&A case.
- (ii) The promotion to Sr.Scale of Shri Arvind Kumar,(Sl.No.4) is on regular basis and Shri Kumar may opt for fixation of pay within 01 month from the date of taking over charge in terms of Estt.Srl.No.99/17 dated 02.08.17.
- (iii) The promotion of Sri Satya Prakash (Sl.No.6/DITS-18.02.15) to Sr.Scale is on adhoc basis and will draw charge allowance up to 17.02.19 i.e till he completes 04 years service. Sri Prakash may opt for fixation of pay with 01 month from the date of regular promotion in terms of Estt.Srl.No.99/17 dated 02.08.17.
- (iv) The date on which the above changes take place should be advised to this office.
- (v) The promotion to Sr.Scale of Shri A.K.Gupta (Srl.No.8) & Shri O.P.Pandey(Srl.No.10) are on adhoc basis and the officers will draw their pay under normal operation of rules.
- (vi) The above promotion is provisional and subject to outcome of the main SLRs and the contempt petition mentioned in RBE No.117/2016 ibid in this regard.
