

The following orders are issued with the approval of the Competent Authority:-

1. Shri Sachin Kumar, JS/IRSME, ADME/Chg./HTE, on being empanelled for promotion to Sr.Scale vide this office Memo. No.SER/P-HQ/DS (Conf.)/Mech./Panel/2018/48 dated 12.03.2018 is promoted to Sr. Scale and posted as DME/ADA vice Shri Kunal Kumar proceeding on 45 days sanctioned LAP from 09.04.2018 to 23.05.2018.
2. The Sr.Scale post of DME/D/BKSC which was downgraded to Jr.Scale as ADME/D/BKSC vide this office order No.42/2018 dated 14.02.2018 is restored to Sr.Scale.

- (iii) Shri Sachin Kumar may exercise option for fixation of pay in Senior Scale from the date of his next increment in terms of RBE No.79/2017(Estt. Srl. No. 99/2017).
- (iv) Shri Nikhil Vaibhav will draw the prescribed charge allowance in addition to his Jr.Scale pay in terms of Estt.Srl.No.90/2010 till he completes 04 years service on 09.06.2018. Thereafter, fixation of his pay in Senior Scale will be under normal operation of rules. Shri Vaibhav may opt for fixation of his pay in Senior Scale on completion of 04 years service from the date of his next increment in terms of RBE No.79/2017(Estt. Srl. No. 99/2017).
- (v) The above promotion to Senior Scale is provisional and subject to outcome of Contempt Petition mentioned in RBE No.117/2016 ibid in this regard.
