2. They have to undergo on job practical training for a period of two years and after completion of training their provisional promotion will be regularized subject to passing the trade test vide Para 9.2.8(a) of Estt. Srl. No. 021/2011.
3. The probation period in provisional promoted post will commence for the date of such promotion and "on the job practical training" will run concurrently with probation and this will also count for seniority and towards minimum period of service prescribed for further promotion. However, the question of further promotion will arise only after the provisional promotion stands regularized after fulfillment of conditions stipulated in the relevant instructions vide Para 9.2.8(d) of Estt. Srl. No. 021/2011.
4. The above employees are eligible to opt for fixation of pay in the promoted grade in terms of Rly. Bd's lr. No. P&A(1/81-22-3, dtd. 13.11.1981, Estt. Srl. No. 231/81) and RBE No. 79/2017. Option may be exercise as usual vide Para 9.2.5 of Estt. Srl. No. 021/2011.
