
The selection shall comprises of written examination test as per guide line circulated in terms of Estt.Srl.No.154/06 & 44/09 perusal of service records.

Pre-selection coaching is not required as there is no reserve community candidate in the zone of consideration. It is made clear that if any candidate is subsequently, found in-eligible for the above selection at any stage his candidature will be rejected without assigning any reason.

This should be given wide publicity amongst the eligible staff and care should be taken to avoid any complaint of non receipt of information. If anyone expresses unwillingness for the written examination, the same should be informed to this office well in advance.

No supplementary written test will be held without valid reason, covered by existing rules.


