In terms of Estt.Srl.No.72/17,the serving regular non ministerial employees in Operating and Commercial Deptt with a minimum of 03 years of regular service, working in GP.Rs.1800/-(level-1) to GP.Rs 2400/-, (Level-4) up to 40 years of age (45 years in case of SC/ST) and educational qualification of Graduation are eligible to apply for the above selection.

Applications are, therefore, invited from the willing staff of Operating and Commercial Deptt. who fulfill the above eligibility conditions.

03 years of service should have been completed on or before the date of issue of this notification.

Scheme of Examination:

The examination will consist only of written test to adjudge the professional ability of the candidates.

The examination should be a substantially higher standard than that of normal selection for the post of Goods Guard against 60% DPQ.


The candidates will have to pass the Medical Examination in A2 classification for promotion to the post of Goods Guard.


