1. The promotion will take effect from the date on which the employee assumes higher responsibilities. The date on which the above changes along with the date of joining in higher grade posts must be intimated to this office in duplicate.
2. There is D&A/SPE/Vig. case in pending against above employee. However, the above promotion is subject to the condition that the employee is being free from D&A/SPE/Vig. case and he is not under suspension and not undergoing any penalty.
3. In terms of RBE No. 117/2016 dtd. 30.09.2016, the promotion order in respect of above employee is provisional, subject to the outcome of the pending contempt petition Civil No.314/2016 and SLP Civil No. 4813/2012 pending in Supreme Court.
4. The promoted employee may exercise option if he want his pay to be fixed from the date of accrual of next lower grade increments, in terms of Rule 1313 of R-II, Rly. Bd's Ir. No. P&A(1)/81-22-3, dtd. 13.11.1981 (Estt. Srl. No.231/81) and RBE No. 79/2017, within one month from the date of promotion. Any option received after one month will not be entertained under any circumstances. Option once exercise shall be final. If the above employee has already granted financial upgradation under MACPs in his hierarchy shall be not entitled for fixation of Pay on promotion.
