


Sub.: Filling-up of posts of Multi-Tasking Staff (erstwhile Group 'D' post) in Railway Board by absorption basis in Level-1 of Pay Matrix (pre-revised: Pay Band-1 (Rs.5200-20200) and Grade Pay Rs.1800) from the employees of Zonal Railways/ Production Units.

As you are aware, applications have been invited to fill up 139 posts of Multi-Tasking Staff vide this office letter of even number dated 08.08.2018. However, complaints are being received from the employees as well as National Federation of Indian Railwaymen (NFIR) that Zonal Railways have neither circulated the above mentioned letter dated 08.08.2018 on the subject, nor are forwarding their applications. Considering these complaints, it has been decided to extend the last date of receipt of duly forwarded application forms from 07.09.2018 to 05.10.2018.

2. It may, however, be noted that the eligibility criteria, date for counting the eligibility criteria and other conditions as mentioned in Board's letter of even number dated 08.08.2018 will remain the same, i.e., as on 07.09.2018.
