




N. B.:

- 2) The above named staff are hereby directed to undergo necessary training, as applicable in their case, at ZRTI/Sini as per Revised Training Modules of Traffic(Commercial Deptt) in terms of Railway Boards letter No.- E(MPP)2009/1/34, Dtd.31.01.2017 and Principal/ZRTI/Sini's letter No.- ZRTI/SNY/Rev.Trng.Moduls/17, Dated: 22.03.17.
- 3) The above promotion order should be given effect subject to free from any punishment DAR other than stoppage of Pass/PTO etc.
- 4) The above named staff may opt within one month from the date of taking over charge for their fixation of pay in terms of Estt. Sl.No.143/08 & 99/17.
- 5) Those who have got financial up gradation of GP Rs 4600/- Level-7(RSRP'16) or above under MACP Scheme earlier, no pay fixation is admissible further to those staff under this promotion order. They will be regularized only to the post of CTI in Comml. Deptt.
