In terms of Railway Board's letter No. E(NG) II/7007/RC-4/CORE/1 dated. 16.10.2017 and 12.12.2017, it has been decided to fill up the following 1(One) Vacancy of cook in Level -2 (7<sup>th</sup> CPC) for PCPO Office/HQ/GRC in South Eastern Railway by re-engagement of staff who have retired from Railway Services as Group C :-

Applications of the desirous eligible retired employees of the same Category/Trade in prescribed Proforma (enclosed herewith – at Annexure-'A') may be sent to Chairman, Railway Recruitment Cell, South Eastern Railway, 11, Garden Reach, Kolkata-700043 by 02.06.2019 at 18.00 hours, super scribing on the envelope "Application for Re-engagement in PCPO's Department/SER/GRC in Railway Service" by the candidates who are willing to apply against vacancy of PCPO Office.

- 1) The scheme is valid upto 01.12.2019 or attaining the age of 65 years or till the availability of regular candidates which ever is earlier.
- 2) Maximum upper age limit for re-engagement in 65 years as on 01.12.2019. No re-engaged employee should continue in service beyond 65 years of age.
- 3) The administration is at liberty to terminate the services of the re-engaged employees even before 01.12.2019 in case their work/conduct is found unsatisfactory.
- 4) The employee Removed /Dismissed/ Compulsory retired as a result of disciplinary action or in review are not eligible for re-engagement. Further, employees retired under SRRS/LARSGESS will not be eligible.
- 5) The re-engaged employees are entitled only for monthly remuneration determined by reducing pension from his/her last pay drawn (i.e. Basic Pay + DA) at the time of retirement. The monthly remuneration + full Pension shall not exceed the last pay drawn at the time of retirement.
- 6) The re-engaged employee will not be eligible for any kind of leave (like CL, LAP, Sick Leave etc.). For absence if any, appropriate deduction will be made from the monthly remuneration. The Duty hours of the re-engaged employee should be same as applicable to the post against which he/ she is re-engaged and should be willing to work anywhere within the concern Unit.

- 7) The re-engaged employees are not entitled for any other additional benefit or facilities except the monthly remuneration.
- 8) The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
- 9) Re-engagement shall be subject to prescribed medical fitness for the relevant category.
- 10) Suitability /Competency of the applicant shall be adjudged by nominated committee before their re-engagement.
- 11) Panel for re-engagement will be prepared on the basis of skill / competency assessment by the nominated committee with the following criteria:-

A	APARs for the last 3 years.	:	15 marks
B	Marks for awards receipt (Board/Zone/Divn./ WS)	:	05 marks
C	Assessment by Committee Members(Past experience of day to day official work pertaining to PCPO Office/GRC/ Safety Record / Relevant field knowledge/ Competency/ Past Record/Amenability to discipline including DAR cases involved in during his /her entire service and their out come)	:	20 marks
<b>TOTAL</b>			40 marks

(at least 60% marks to be obtained in total and Minimum 12 marks in APAR to be empanelled in both Safety & Non-safety category)
