It has been decided by the competent authority to hold a selection to form a panel of 08(eight) candidates (UR=04, SC=03, & ST=01) for the post of Section Controller in GP.Rs. 4200/- 6th CPC/Level-6 of 7th CPC through mode of General Selection (Estt Srl No 189/09)

Therefore options are invited from the following eligible categories of staff of Operating department.

- (1) Guard of all grades in level-5 & 6 GP.Rs.2800/- & 4200/- (7th CPC)
- (2) SMs in level-6 GP.Rs.4200/- (in 7th CPC).

The applicants must be below the age of 48 years and with minimum 02 years of service as on **30.05.2019 (date of notification)** may appear for the post of Section Controller. The reserved community candidates should enclose attested photocopy of caste certificate along with their applications.

Eligible SC/ST candidates should be imparted pre-selection coaching for 03 to 04 weeks in terms of Estt.Srl.No.24/98 and the coaching completion certificates should reach to this office before the original written test.

It may be noted that the selection of the staff in level-6 (GP Rs 4200/-) to the post of Section Controller in level-6 (GP Rs 4200/-) may be treated as parallel movement, therefore no fixation benefit will be allowed.

The staff fulfilling the above conditions may submit their applications/options as per enclosed proforma to their Unit in-charges who will receive the applications/options up to **21.06.2019 (i.e last date)** and forward the same in a bunch to the office of Sr.DOM/Adra, which in turn will send the same to this office by **24.06.2019**. It is made clear that no application/option will be accepted by this office after **24.06.2019**


This should be given wide publicity amongst the eligible staff and care should be taken, to avoid complaints of non-receipt of information from any unit.


