

General Manager,S.E.Rly,GRC has accorded his approval on inclusion of following S.E.Rly.
stations under jurisdiction of one PRINCIPAL STATION for issue of Railway Passes/PTOs as indicated below-

- (1) Shallimar(SHM) and Santragachi(SRC) stations have been included with Howrah,Sealdah,Kolkata(KOAA) under jurisdiction of one principal station HOWRAH In KOLKATA Metropolitan City.
- (2) JOYCHANDIPAHAR(JOC) station has been included with Adra under jurisdiction of one principal station ADRA.

Principal Project Engineer/CRIS/Kolkata has confirmed that above inclusion of stations under one Principal station has been released in PRS. Thus, with immediate effect Railway Passes/PTOs should be issued indicating names of the Cities as indicated above instead of giving specific name of the stations and tickets can be booked from any station falling within the jurisdiction of that particular area subject to the following conditions as laid down by Railway Board:

- (a) The passes may not be valid for the entire Suburban Section.
- (b) Adequate safeguards may be taken that this facility may not be misused for undertaking short distance journeys.

You are requested to recirculate the Instructions to all Pass/PTO Issuing Offices/depots for implementation with immediate effect.
