- (5) Option for fixation of pay as per Estt.Srl.No.231/81 and 37/09 should be submitted 30 days from the date of promotion if desire.
- (6) If benefit of pay fixation has been earned at the time of financial up gradation under MACP, there shall be no further fixation of pay at the time of regular promotion, only difference of pay would be made available if it happens to be in a post carrying higher grade pay.
- (7) Rules regarding vacation of Rly.Qrt. will be apply.


- (8) These orders are provisional and are subject to the final outcome of ongoing litigations/court cases on the subject in terms of Estt.Srl.No.233/18.
