Sub- Re- Engagement of Retired staff on monthly remuneration basis in exigencies of service in Adra Division, S.E.Railway.


In terms of Railway Bords's letter no 2017/Trans/01/Policy/Pt.I dated-17.01.18 Circulated under CPO/GRC vide his letter no- SER/P-HQ/ED/Cadre/147 dated -23.08.18. It has been decided to fill up the following vacancies of Para Medical Staff in Medical Department of Adra Division by Re- engagement of Staff from among the retired employees of Adra division, S.E.Railway.

Therefore, applications are called for from the deserving retired Railway staff of Adra Division. S.E.Railway to reach Medical (Genl) Section of Sr.DPO's office through the DROP BOX placed at Medical Genl Section of Sr.DPO's office /S.E.Railway /Adra on or before 05.09.19

The following terms of conditions may kindly be noted-

1. The scheme is valid up to 01.12.19
2. Those employees who have retired from the categories mentioned above (in the eligible ex- employees Colum) of the Medical department of Adra Division. S.E.Raliway can only apply for the post of which notification is issued.
3. The Re- engagement shall be strictly valid up to 01.12.19 or on attaining the age of 65 years of re-engagement employees or till the availability of regular candidates from RRC/RRB/Departmental Selection whichever is earlier.
4. Maximum age limit for re-engagement is 65 years as on 01.12.19. Hence, the candidates should be born after 02.12.54. No re-engaged employee should continue in service beyond 65 years of age.
5. The administration is at liberty to terminate the service of re-engaged employees even before 01.12.19 in case their work/conducted is found unsatisfactory by given a notice of 07 days.
6. The employees Removed/Dismissed/Compulsorily retired as a result of disciplinary action during review of(55 years of age/30years of service) are not eligible for re-engagement . Further employees retired under SRRS/LARSGESS will not be eligible.

6. The employees Removed/Dismissed/Compulsorily retired as a result of disciplinary action during review of(55 years of age/30years of service) are not eligible for re-engagement . Further employees retired under SRRS/LARSGESS will not be eligible.

7. The Re-engaged employees are entitled only for monthly remuneration i.e reducing pension from his/her last pay drawn (i.e Basic + DA) at the time of Retirement. The monthly fixed remuneration plus full pension shall not exceed the last pay drawn at the time of retirement.

8. The Re-engaged employees will not be eligible for any kind of leave (like CL, LAP, Sick Leave etc). For absence if any, appropriate deduction will be made from the monthly remuneration.

9. The Re-engaged employees are not entitled for any other benefit or facilities except the monthly fixed remuneration.

10. The retired employees shall execute and agreement to abide by all the terms and conditions of the re-engagement.


11. Re- engagement shall be subject to Medical fitness for the above mentioned categories.

12. Suitability /Competency of the applicant shall be adjudged by nominated committee before their re-engagement.

13. Copy of the following documents should be mandatory attached with the application.

(a) Service Certificate,(b) Pensioner Identity Certificate.(c) Pension Payment Order.(d) Termination Office Order, (e) Aadhaar Card, (f) PAN Card.

14. The last date of the submission of the application is 05.09.19 Staff retired from Adra Division, S.E.Railway desirous for re-engagement have to submit their applications in the prescribed format at Annexure-A in the Drop Box kept in respective General Section of Sr.DPO's Office/Adra on or before by 18.00 hrs.
