
Notification of selection for promotion to the post of TE(Ticket Examiner) in
GP.Rs.2000/- (Level-3) of 7th CPC against 16.67% DPQ in Commercial Department
has been issued vide this office Notification cited under reference No. (1) Where in staff
of Operating Deptt. and Comml. Dept. in Level-2 including Pointsmen are considered
under zone of selection.

Hence subsequently, clarification was issued further in reference to the above
that S.E.Rly should follow Estt. Srl. No.82/2018 (RBE No.28./18) vide PCPO/GRC's
letter under reference (3) where in only staff of Operating Deptt. and Commercial Deptt.
in erstwhile GP. Rs.1800/- of 6th PC (Level-1 of 7th CPC) are to be considered for
combined post of CC-cum-TE. However above clarification was not followed
inadvertently this has led to irregularities in the selection.

Hence, the Selection for promotion to the post of TE (Ticket Examiner) in
GP.Rs.2000/- Level-3 of 7th CPC against 16.67% DPQ against this office Notification
under reference (1) is hereby cancelled with the approval of the competent authority. As
such, the panel approved for promotion to the post of TE (Ticket Examiner) in Level-3 is
also treated as cancelled.

Fresh Notification as per above guide line will be issued shortly.
