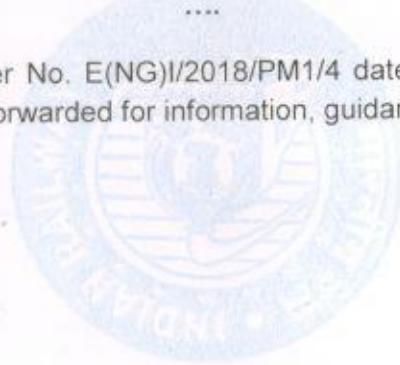



- There will be negative marking@ 1/3 mark for a wrong answer for all selections, including LDCE where panel is arranged in the order of merit from those qualified.
- Negative marking to continue for GDCE as for RRB examinations.
- Selections conducted otherwise need not be re-opened.
