Sub: Selection for formation of a panel of ACM/ACO (Group-B) against 70 % vacancies in SER

It has been decided by the Competent Authority that the written test for formation of a panel of ACM/ACO (Group-B) against 70% vacancies for **03 posts (UR-02, SC-01)** will be held shortly. Accordingly, based on the list of willing, eligible candidates, as provided by the concerned Staff Officer, the Zone of Consideration (ZoC) has been decided and the provisional list of 12 candidates, as per their integrated seniority position is enclosed as Annexure-A.

Efforts may be made to ensure acknowledgement of this 'ZoC' among the candidates concerned. In case any candidate is on leave or on deputation to other Railways / Units or on sick list, the Controlling Officer concerned should send necessary advice to the authority under whom he/she is working or the Medical Authority as the case may be and an acknowledgement obtained.

Scheme of Examination:- The examination will consist of (i) **Written Test & (ii) Viva voce**

In terms of Railway Board's letter No. E (GP)2018/2/31 dated 19.03.2019 (RBE 53/2019) the written examination shall comprise of **one Paper** which will have **100% Objective type Multiple choice Questions** only. There shall be no negative marking for wrong answers, in terms of RBE 194/19.

The paper will be of **100 marks** and distribution will be as under:

- a. Technical Subject including Official language policy : 70 marks
(NOTE: There will be 10 marks on Official Language Policy, which shall be optional in nature).
b. Establishment and Financial Rules : 30 marks

Qualifying marks:

: 60 (out of 100)

The successful candidates in the written examination will be called for viva-voce test subject to being found medically fit in the prescribed medical standard. Viva-voce will consist of: Record of Service (Assessment of APAR) and Viva-voce.

Final panel will be drawn on the basis of overall performance in the written examination and viva-voce and in order of seniority from among the successful candidates.


Pre-Selection coaching: Prior to the written test, a mandatory pre-selection training of 3-4 weeks will have to be imparted to the SC candidates featuring in the Zone of Consideration. If any reserved community candidate is unable to undergo the training, in such case, a written acknowledgement should be invariably obtained from him/her and kept on record. After, completion of training, a detailed report should be sent to this office.

Date of Written examination: Will be conducted shortly after the completion of the pre-selection training. All candidates may be advised to be in readiness accordingly.
