

Before sending the APARs, please ensure that adverse remarks or the point below the bench mark in APARs has been communicated to the candidate and representation, if any, received was disposed of promptly and decision of the Competent Authority has been indicated in the APAR.

In terms of Board's letter No. E(GP)80/2/8 dated 31.10.1991 only those candidates who qualify in the medical examination of prescribed standard should be advised to appear in the viva-voce test.
