- 1) The above named staff have been empanelled for the post of Sr Good Guard in Level-6 (RSRP-16) vide this office memorandum No SER/P-ADA/ET/210/14/ Sr Good Gd/Result(Part) Adra dtd. 06 12 2019
- 2) The promotion order should be given effect if the staff concerned is free from any punishment under DAR other than stoppage of Pass/PTO on the date of effecting of promotion. *The above named staff are free from SDE/192 D2A cases as on date.*
- 3) Pay of the above may be fixed on promotion as per extant rules. The staff may opt for fixation of pay from the date of their next increment in terms of Estt Sri No 99/2017 within 01 month if they think it beneficial to them.
- 4) The above promotion to the post of Sr Good Guard in Level-6 is provisional and the period of probation is of twelve months. On completion of the prescribed period the appointing authority will assess the work and conduct of the Railway servant himself and in case the Railway servant found fit to hold the post of Sr Good Guard in Level-6 he will pass an order declaring that the person concerned has successfully completed the probation. If the appointing authority considers that the work of the Railway servant has not been satisfactory or needs to be watched for some more time, he may revert him to the post of Good Guard in Level-5, or extend the period of probation as the case may be in terms of in the Master Circular No 19 (updated June-2019) circulated vide S E Railway's Estt. SI.No. 111/2019
- 5) This order is provisional and is subject to the final outcome of ongoing litigations/Court cases on the subject.
- 6) Date of taking over higher charges of the above named staff should invariably be intimated to this office for record.
- 7) This issues with the approval of the competent authority on the recommendation of the Placement Committee.
