The following order is issued with the approval of the competent authority:

Shri Sirugudi Uday Kumar, Retired AOM(Chg)/KGP, on being found medically fit for the Gr. 'B' services, is appointed as Consultant (Coaching Operations) of Operating Department of Kharagpur Division of this railway with the terms and conditions as enumerated hereunder:

1. The re-engagement is purely on temporary measure for one year or till a regular incumbent is available through selection or till the validity of the scheme, whichever is earlier. Extension beyond the one year period, if considered essential, shall only be done with the approval of the General Manager. However, this will be subject to validity of the scheme beyond 25.10.2020. In terms of Railway Board's Re-engagement Notice No. 02/2019.
2. Shri S. Uday Kumar shall be entitled for 12 days of leave in a calendar year on pro-rata basis. No other leave under the Leave Rules, e.g. LAP/LHAP/Commutation, etc. is applicable to him. Any absence from duties beyond the leave period shall be deducted from the monthly remuneration. However, he will enjoy the closed holidays and the days on which the office remains closed.
3. He will be entitled for the monthly remuneration by reducing the pension he is in receipt of from his last pay drawn. His present Original pension is Rs. 46,500/- per month and his last pay drawn before retirement was Rs. 93,000/- (Level-9) per month.
4. The T.A./D.A. as admissible to the working Jr. Scale/Gr. B officer, while on duty, shall also be admissible to Shri S. Uday Kumar for outstation duties. Duty Passes, as admissible, for these purposes can also be issued in his favour. However, he is not eligible for any Privilege Pass/P.T.O./HRA/ Conveyance allowance etc. against his services as the Consultant. He will continue to have the post-retirement Complimentary Passes issued in his favour.
5. He shall not be given any financial and disciplinary powers and shall not be authorised to issue any Safety or any kind of Certificate.
6. He shall not divulge any information gathered by him during the period of such re-engagement to anyone who is not authorized to access the same.
7. Such re-engagement must not be construed as a right to appointment and can be terminated by the Administration at any point of time with or without showing any reason thereof.

His suitability for re-engagement as the Consultant (Traffic) has been issued vide PCPO's Memorandum No. SER/P-HQ/GAZ-CON/Re-engage/Constt(T)/19 dated 03.01.2020, in terms of Railway Board's Letter No. 2018/Trans Cell/S&T/Contractual Staff dated 25.10.2018.
