- (1) The above named staff have been found suitable for promotion to the post of OS(Office Group) in Pay Level-6 (RSRP-16) vide this office memorandum No.SER/P-ADA/ET/210/14/OS(Office Group)/352/19 dtd. 09.12.2019.
- (2) The promotion order should be given effect if the staff concerned is free from any punishment under DAR other than stoppage of Pass/PTO on the date of effecting of promotion.
- (3) The promotional office order of the above named staff are issued free from SPE/Mig. & D&A case for promotion to the post of OS (Office Group)
- (4) The pay of the staff will be fixed as per extant rule. The staff may opt for fixation of pay from the date of their next increment in terms of Estt. Srl No 99/2017 within 01 month, if beneficial to them.
- (5) The above promotion to the post of OS (Office Group) in Pay Level-6 is provisional and the period of probation is of twelve months. On completion of the prescribed period the appointing authority will assess the work and conduct of the Railway servant himself and in case the Railway servant found fit to hold the post of OS (Office Group) in Pay Level-6 he will pass an order declaring that the person concerned has successfully completed the probation. If the appointing authority considers that the work of the Railway servant has not been satisfactory or needs to be watched for some more time, he may revert him to the post of Sr Clerk (Office Group) in Pay Level-5, or extend the period of probation as the case may be in terms of in the Master Circular No.15 (updated June-2019) circulated vide S E Railway's Estt. Srl No. 111/2019.
- (6) The date of taking over independent charge should be intimated to this office for record.
- (7) The staff who have got the financial up-gradation in Pay level-6 under MACP scheme earlier, are not entitled to get further fixation of pay at the time of regular promotion in the same Pay level. They will be only regularized to the post of OS (Office Group).
- (8) The promotion order is provisional and subject to the outcome of SLP(C) No. 4831/2012 and Contempt Petition (C) No. 314/2016- Samta Andolan Samiti through President -Vs-Sanjay Kothari & others.
- (9) This issues with the approval of the competent authority on the recommendation of the placement committee.
