Any representation against the eligibility list should be made in writing to SPO (HQ)/GRC within 15 (fifteen) days from publication of this letter. In case, no representation is received within the stipulated time, this candidature will be treated as final and no further request will be entertained.

The above mentioned candidate should be intimated to get himself prepared for appearing in the selection. In case he is on leave or on deputation to other Railways / Units or on sick list, the Controlling Officer concerned should send necessary advice to the authority under whom he is working or the Medical Authority as the case may be and an acknowledgement obtained.

**Objective of Examination:** The examination aims at a comprehensive assessment of knowledge of the candidates and has essentially to be a rigorous test of their professional ability.

**SCHEME OF EXAMINATION:**

In terms of Railway Board's letter No. E(GP)2018/2/31 dated 19.03.2019(RBE 53/2019) the written examination shall comprise of **one Paper** which will have **100% Objective type Multiple choice Questions** only with negative marking for wrong answer. The paper will be of **100 marks** and distribution will be as under:

- i) Technical Subject including Official language policy: 70 marks  
(NOTE: There will be 10 marks on Official Language Policy, which shall be optional in nature).
- ii) Establishment and Financial Rules : 30 marks
- iii) **Qualifying marks:** : 60 (out of 100)

The successful candidate in the written examination will be called for viva-voce test subject to being found medically fit in the prescribed medical standard. Viva-voce will consist of:


