

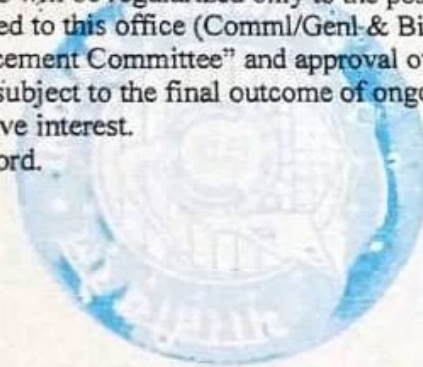

- 1) The above named staff have been declared suitable for promotion to the post of Sr.TE in Pay Level-5(RSRP'16) vide Sr.DPO/Adra's Memorandum No.SER/P-ADA/EC/1/210/Sr.TE/2020, dated 30.04.2020.
- 2) The above promotion order should be given effect on completion of two years regular service of the staff concerned in their existing post.
- 3) The above named staff are hereby directed to undergo necessary training, as applicable, at ZRTI/Sini as per Revised Training Modules of Traffic (Commercial Deptt) in terms of Railway Boards letter No.- E(MPP)2009/1/34, Dtd.31.01.2017 and Principal/ZRTI/Sini's letter No.ZRTI/SNY/Rev.Trg. Moduls/17, Dated: 22.03.17.
- 4) The above promotion to the post of Sr.TE in Pay level-5 is provisional and the period of probation is of twelve months. On completion of the prescribed period the appointing authority will assess the work and conduct of the Railway servant himself and in case the Railway servant found fit to hold the post of Sr.TE in Pay level-5 he will pass an order declaring that the person concerned has successfully completed the probation. If the appointing authority considers that the work of the Railway servant has not been satisfactory or needs to be watched for some more time, he may revert him to the post of TE in Pay Level-3, or extend the period of probation as the case may be in terms of in the Master Circular No.19 (updated June-2019) circulated vide S.E.Railway's Estt. Sl. No. 111/2019.
- 5) There is no SPE/VIG. and D&A case pending against the above named staff.
- 6) The above promotion order should be given effect subject to free from any punishment DAR other than stoppage of Pass/PTO etc.
- 7) The above named staff may opt within one month from the date of taking over charge for fixation of pay in terms of Estt. Sl.No.99/17.
- 8) If any of the staff has got financial up gradation to Level-5 (BSRP'16) or above under MACP Scheme earlier, no pay fixation is admissible further to the staff under this promotion order. He will be regularized only to the post of Sr.TE in Comml. Deptt.
- 9) The date of taking over charge should be intimated to this office (Comml/Genl. & Bill Sec.) for record.
- 10) This issues with the recommendation of the "Placement Committee" and approval of Sr.DCM/Adra.
- 11) The above promotion order is provisional and is subject to the final outcome of ongoing litigation/court cases on the subject.
- 12) The above posting order is issued on administrative interest.
- 13) Necessary entry may be made in the Service Record.
