

The following orders are issued with the approval of the General Manager: -

1. The existing vacant JAG post of Dy.CEL/LOCO/HQ/GRC (Post code-04SE5P004) is downgraded to Sr. Scale on temporary basis and redesignated as ELE/LOCO/HQ/GRC by terminating the additional post allowance made vide this office order no. 27/20 dated 03.02.20 in favour of Sri A.K.Prusty.
2. Shri Amit Yadav (SS/RSF), ex.Principal (ELTC/TATA), on return from Study Leave and reporting for duty on 08.06.2020 is transferred and posted as ELE/LOCO/HQ/GRC (post code-04SE5P004) against the post indicated at item -1 above.
3. The Sr.Scale post of DEE/CTRC/TATA (Post Code-04SE6P005) which is being operated in Jr. Scale as ADEE/CTRC/TATA vide this office order no. 31/20 dated 05.02.20 is restored for operation as DEE/CTRC/TATA.
4. The Sr. Scale post of DEE/TRS/BKSC (Post Code-04SE6P008) which is being operated in Jr. Scale as ADEE/TRS-III/BKSC vide this office order no. 175/2019 dated 24.06.19 is restored and transferred to Construction Organisation for its operation as DEE/CON/RNC.
5. The vacant JS/Gr.B post of ADEE/TRD/CKP is transferred to TATA and re-designated as ADEE/CTRC/TATA and the present incumbent of the post of ADEE/CTRC/TATA (item-3 above), Shri R.P.Meena will continue to work against the re-designated post.
6. The vacant JS/Gr.B post of ADEE/TRD/ADA is transferred to BKSC and re-designated as ADEE/TRS-III/BKSC and the present incumbent of the post of ADEE/TRS-III/BKSC (item-4 above), Shri A. Kusumayinav will continue to work against the re-designated post.
7. Shri S.N. Mishra, DEE/CON/CKP is transferred and posted as DEE/CON/RNC (Post Code-04SE6P008) against the post indicated at item-4 above.

NB:

1. The period from 08.06.2020 to 11.06.2020 is treated as 'Waiting for posting' in favour of Shri Amit Yadav, ex.Principal/ELTC/TATA. (ii) The date of assumption of charge may please be advised.
2. Consequent upon retirement of Shri A.K.Bhowmik w.e.f. 30.04.2020, the Sr.Scale post of DEE/CON/RNC will be kept 'Frozen' and not to be operated over the next 05 years as per this office memorandum dated 23.10.19.
3. With the vacation of DEE/CON/CKP post (which is Deemed non-existent post) by its present incumbent, Shri S.N.Mishra, this post lost its entity and shall not be operated.
