- 3) The contractual engagement shall not confer any right for regularization or absorption in the post.
- 4) Candidate should not exceed 65 years of age as on 01-07-2020 with good health condition. **Candidates who have already completed 12 terms of previous engagement as CMP in Indian Railways are not entitled.**
- 5) For retired Govt.(Railway/Central/State/PSU) doctors, age should be within 65 years as on 01.07.2020 with good health condition. **(1<sup>st</sup> priority will be given for the retired Govt/ Railway/ Central/State/ PSU) Doctors for such engagement, if not then from GeM/Open Market.**
