The following order is issued with the approval of the competent authority:

1. Shri Sanjay Kumar, Ex. Section Officer (ad-hoc) of Railway Board Secretariat Service (RBSS) is deputed to South Eastern Railway, Kolkata, for a period of three years or until further orders, whichever is earlier: and reporting to this Railway on 08.08.2020 is posted as ACM/RNC, against an existing vacancy.
2. His lien during the period would remain with RBSS. The broad terms and conditions would be as applicable as illustrated in Railway Board letter No. ERB-I/2019/8/7 dated 30.06.2020:
 - i. He will be entitled to transfer allowance, joining time etc. as per normal rules, in the case of transfer. However, no deputation allowance shall be admissible.
 - ii. For the purpose of TA/DA, the head of the department where he is posted for the time being, will act as the Controlling Officer.
 - iii. **Medical facilities:** During his posting on the Zonal Railway, he would be entitled to the facility of CGHS and if the same is not available, he will be given benefit of the railway medical facility for self and family as per entitlement.
 - iv. **House Rent Allowance:** He would be entitled to draw House Rent Allowance, at his new place of posting as per his entitlement, in case he is not provided the railway accommodation.
 - v. Subscription towards Group Insurance Scheme will be recovered from his salary.
 - vi. He will continue to subscribe to the Provident Fund/NPS, as applicable to him.
 - vii. For any further clarification, the matter can be referred to Board, if required.
