

The following orders are issued with the approval of the Competent Authority:-

- 1 The SAG element of the post of CMS/BNDM which was initially transferred to Central Hospital, Garden Reach temporarily for its operation as Chief Specialist/CH/GRC vide O.O.No. 163/2016 dated 10-08-2016 and subsequently extended upto 24.09.20 vide O.O. No. 266/2019 dated 17-10-2019, should be continued at Central Hospital, Garden Reach as Chief Specialist/CH/GRC for a further period of one year w.e.f. 25.09.20. Dr. A.K.Malhotra (NF-HAG/IRHS), Chief Specialist (Surgeon)/CH/GRC will continue against the said post.
- 2 The SAG element of the post of CMS/Tata which was initially transferred to Central Hospital, Garden Reach temporarily for its operation as Chief Specialist/CH/GRC vide O.O.No. 182/2016 dated 01-09-2016 and subsequently valid upto 24.09.20 vide 266/2019 dated 17-10-2019 should be continued at Central Hospital, Garden Reach as Chief Specialist/CH/GRC for a further period of one year w.e.f. 25.09.20.
- 3 Dr. A. Kirtania (SAG/IRHS) Chief Specialist (Orthopaedics)/CH/GRC is posted as CHD/PCMD's Office/Garden Reach in the same capacity against an existing vacancy of pin-pointed SAG/IRHS post
- 4 Dr. Sushil Kumar Behera (SAG/IRHS-DACPS), ACMS/TATA is transferred to KGP and posted as CMS/KGP against an existing vacancy of pin-pointed SAG/IRHS post, terminating the dual charge arrangement of Dr. S.A. Nazmi, ACMS (Path)/KGP issued vide this office O.O. No. 312/2019 dated 13-12-2019
- 5 Dr. Santanu Basu Roy (SAG/IRHS-DACPS), ACHD (Orthopaedics) CH/GRC is posted as Chief Specialist (Orthopaedics)/CH/GRC against the pin-pointed SAG/IRHS post vide item number (2) above, vacated by Dr. A.Kirtania, Chief Specialist (Orthopaedics)/CH/GRC consequent upon his posting as CHD/PCMD's Office/GRC.
- 6 Dr.Govinda Chandra Hembram (SAG/IRHS-DACPS), ACMS/RNC who is looking after the duties of the post of CMS/RNC vide this office O.O. No. 281/2020 dated 06-11-19, is posted as CMS/RNC against an existing vacancy of pin-pointed SAG/IRHS post.
- 7 Transfer order of Dr. Santanu Basu Roy, ACHD (Orthopaedics)/CH/GRC issued vide this office O.O.No. 57/2020 dated 27-02-2020 is treated as cancelled.
