Matriculation passed or existing Erstwhile Group 'D' staff as on 10.05.1998 having below Matriculation qualification i.e. non-Matric as special case in terms of Estt. Srl. No. 49/11.

3. Length of Service:-

The candidates should have 03(Three) years of regular service as on date of notification.

The empanelled candidates will be required to undergo training for specific period before they are finally promoted to the post of Dresser Gr.-III in terms of Para-182(A) of IREM, Vol-1.
