Further to this office letter of even no under reference, it has been decided to hold a limited departmental competitive examination (LDCE) for filling up of **158 posts (UR=125 SC=22 ST=11)** of Office Superintendent (20% LDCE quota) for all departments **except Accounts and Security Department** of HQ Office/GRC & KOL.

A list of candidates who are provisionally allowed to appear in the written examination is mentioned at **Annexure "A"**. This should be got noted by the candidates of **Annexure "A"**. In case, any candidates is on leave on deputation or working in other Railway/Units or sick list, the controlling officer concerned should send necessary advice to the authority under whom he is working or the medical authority as the case may be and send an acknowledgement obtained. A list of not eligible candidates at **Annexure "B"** is also mentioned.

**Date of the written examination and venue:** Will be notified shortly. Candidates are advised to keep themselves in **readiness for the written examination**.

**Note:** 1) If any candidates subsequently found ineligible for the above selection at any stage his/her candidature will be rejected without assigning any reason.  
2) It may also be noted that there will be no supplementary written test for the absentees under any circumstances.
