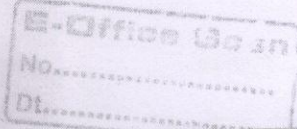

Attention is invited to instructions contained in Board's letter of even number dated 13.05.2019 on the above mentioned subject vide which inter-alia the age limit and tenure of Instructors has been prescribed as under:

- i) Upper age limit as on date of notification should be 52 years.
- ii) Minimum 3 years and maximum of 8 years in the Training Institute.

The aforesaid age limit and tenure of Instructors of the Training Institutes has been reviewed by the Board and it has been decided that the upper age limit should be 55 years and tenure should be 5 years.
