
Main examination shall consist of only one descriptive type paper on professional subject comprising 100 marks and the qualifying marks in the written examination will be 60%.

(Note: As per IREM, Vol.-I, Para 204.3, 10% marks of the total marks in the Pre-qualifying examination and main examination will be set apart for question in Official Language. The question on Official Language will not be however, compulsory in nature.)

SYLLABUS: The existing Syllabus for Professional subjects of Traffic (Transportation & Commercial) Department issued by Railway Board is available in **SER's Estt.Srl.No.48/2007 & 119/2008** will be the syllabus for Professional subjects for the Main Examination.

The notice should be got noted by all the candidates.
