The following orders are issued with the approval of the Competent Authority:-

1. Shri Sudipta Bhattacharya, LO/Comml/HQ is transferred and posted as LO/GM's office/GRC against the vacant Sr.Scale post of Sr.LO/GRC, by downgrading the same.

- (a) The Group 'B' panel of LO has been published vide PCPO/GRC's memorandum no. SER/P-HQ/GAZ-CON/260/5/LO/20 dated 27.01.2021 with the approval of the General Manager. Such promotion of Shri Pramod Kumar Srivastava, to Gr.B service is subject to not undergoing any punishment under D&A Rules.
- (b) The post of LO/GRC which was transferred for one year to CKP Division for operation as LO/CKP vide Office Order No.291/2019 dated 20.11.2019 will continue to be operated as LO/CKP for the period of another one year.
- (c) Shri Pramod Kumar Srivastava, on promotion to the post of LO(Gr.B), may exercise his option for fixation of pay within one month from the date of taking over the charge in Gr.B in terms of Est. Srl. No.99/2017.
- (d) The Panel for ad-hoc promotion of Smt. Indira Das(SC) CLA/CCM(Law)/SER from Group 'C' to Group 'B' for the post of LO has been published vide this office memo. no SER/P-HQ/GAZ-CON/260/5/LO/20 (Adhoc) dated 27.01.2021 with the approval of the General Manager. Such promotion in respect of her is subject to her not undergoing any punishment under Vig./SPE/D&A cases.
- (e) The 06(six) months in-service training period in favour of Smt. Indira Das(SC), CLA/CCM (Law)/SER, will be counted from the date of her taking over charge of the post in Gr-B.
- (f) The ad-hoc promotion of Smt. Indira Das(SC) CLA/CCM (Law)/SER, will be regularised after successful completion of 06 months' in-service training and being decided by the competent Authority.
- (g) The above promotion is subject to further guidelines contained in DoPT's F.F.No.36012/11 /2016-Estt.(Res-1)(Pt.ii) dated 15th June, 2018.
- (h) The charge reports for the above changes should be sent to this office immediately.
