(2) The above promotion of the staff concerned will be given effect subject to that they are free from any punishment under DAR such as stoppage of increment, reversion to lower grade pay etc.(other than stoppage of Pass./PTO) and also

free from SPE/Vig/D&A cases on the date of promotion.

(3) The date of release and joining to new station should be intimated to this office for record.

(4) Pay of the above, may be fixed on promotion as per extent instructions and their seniority fixed as per extent rule.

(5) The date of taking independent charges should be intimated to this office for record.

(6) The above promotion to the post of SM in Pay Level-6 is provisional and the period of probation is of twelve months.

On completion of the prescribed period the appointing authority will assess the work and conduct of the Railway servant himself and in case the Railway servant found fit to hold the post of SM in Pay Level-6 they will pass an order declaring that the person concerned has successfully completed the probation. If the appointing authority considers that the work of the Railway servant has not been satisfactory or needs to be watched for some more time, he may revert him to the post

of PM-A in Pay Level-2, or extend the period of probation as the case may be in terms of in the Master Circular No.19 (updated June-2019) circulated vide S.E.Railway's Estt. Sri.No. 111/2019.

(7) The above promotion order is provisional and subject to the out come of the main SLPs and Contempt Petition (C) No.314/2016 in SLP (C)

No.4831/2012-Samta Anodolon Samiti through President-Vs-Sanjoy Kothari and others.

(8) Transfer Rules regarding vacation of Rly. Qrs will apply.
